SPECIAL TOWN MEETING WARRANT
JUNE 21ST, 2016

THE COMMONWEALTH OF MASSACHUSETTS WORCESTER, SS

TO EITHER OF THE CONSTABLES OF THE TOWN OF MENDON, in the county of WORCESTER, greetings:

In the name of the Commonwealth of Massachusetts you are hereby directed to notify and warn the inhabitants of said Town, qualified to vote in elections and in Town affairs, to meet at the **Miscoe Hill School** in said MENDON on the **twenty-first** day of June next, at 7:00 o'clock in the evening, then and there to act on the following articles:

- ARTICLE 1**
(Fin Com) To see if the Town will vote to transfer a sum of money from available funds to Selectmen Professional Services Expenses (Line 122B); or act or do anything in relation thereto.
- ARTICLE 2**
(Fin Com) To see if the Town will vote to transfer a sum of money from available funds to Assessors Professional Services Expenses (Line 141B); or act or do anything in relation thereto
- ARTICLE 3**
(Fin Com) To see if the Town will vote to transfer a sum of money from available funds to Town Counsel Expenses (Line Item 151B); or act or do anything in relation thereto.
- ARTICLE 4**
(Fin Com) To see if the Town will vote to transfer a sum of money from available funds to Planning Board Expenses (Line Item 175B); or act or do anything in relation thereto.
- ARTICLE 5**
(Fin Com) To see if the Town will vote to transfer a sum of money from available funds to Town Hall Services Computer Expenses (Line 199E); or act or do anything in relation thereto.
- ARTICLE 6**
(Fin Com) To see if the Town will vote to transfer a sum of money from available funds to Board of Health Expenses (Line Item 510B); or act or do anything in relation thereto
- ARTICLE 7**
(Fin Com) To see if the Town will vote to transfer a sum of money from available funds to Board of Health Trash Disposal (Line Item 510C); or act or do anything in relation thereto.
- ARTICLE 8**
(Fin Com) To see if the Town will vote to transfer a sum of money from available funds to Board of Health Testing-Landfill, Wells and Beach (Line Item 510F); or act or do anything in relation thereto.
- ARTICLE 9**
(Fin Com) To see if the Town will vote to transfer a sum of money from available funds to Snow and Ice Expenses (Line 423B); or act or do anything in relation thereto.
- ARTICLE 10**
(BOS) To see if the Town will vote to accept "Irons Way" in White Pines Estates subdivision as a public way, as laid out by the Board of Selectmen, provided, however, that the owner(s) of the properties comprising such streets provide(s) to the Town a deed or certificate of title acceptable to the Board of Selectmen with respect to the fee, easement, interest and/or rights in the roadways to be conveyed to the Town, and pay(s) all costs and recording expenses related hereto, and provided that all of the requirements of the Planning Board have been met; or take any other action relating thereto.
- ARTICLE 11**
(BOS) To see if the Town will vote to amend as follows the Town of Mendon General By-laws:

Chapter II Town Meetings, Section 4.

Notices of all Town Meetings shall be given by posting an attested copy of the warrant for such meeting in three (3) or more public places in the Town of Mendon and on the Town of Mendon Website at least fourteen (14) days before said meeting; ~~Copies of all town meeting warrants shall also be delivered by hand or other means to every household.~~

**ARTICLE 12
(CPC)**

To see if the Town will vote to transfer a sum of money from the Community Preservation Budgeted Reserve Account to fund the installation of a drainage system on Tetreault Field, as well as upgrades and repairs to the Veteran's Park outfield; or take any action in relation thereto.

**ARTICLE 13
(LUC)**

To see if the Town will vote to transfer a sum of money from the Mendon Land Bank to fund the installation of a Beaver Solution Device to prevent flooding on Nipmuc Lake; or act or do anything in relation thereto.
